


PLANNING APPLICATION Newsletter

June 2020



The Nicholson Quarter will create a new lease of life for the town through a compelling mix of workplaces, homes, shops and public spaces that bring energy, day and night, weekday and weekend. A variety of streets, yards and spaces will create a place with pace and rhythm, that's ripe for exploration. A place where anticipation rises out of something wonderful to be discovered around every corner.

After just over a year of community participation and design development, the planning application for the transformation of the Nicholsons Shopping Centre into the new Nicholson Quarter has been submitted to Royal Borough Windsor & Maidenhead (RBWM).

This newsletter provides a summary overview of the proposals and is being distributed widely. We will hold a public exhibition of the proposals if and when it is possible in accordance with the Government's Covid-19 guidelines. An exciting opportunity

The Nicholsons Shopping Centre occupies an important location at the heart of the town and its redevelopment provides an exciting opportunity for significant mixed-use regeneration in line with the aspirations of RBWM's Town Centre Area Action Plan.

Just over a year ago Tikehau Capital and partners Areli Real Estate bought the site from receivership and started working closely with the local community to shape the proposals for the transformation of the site and its relationship with the wider town.

Creating the vision

In March last year some 500-people attended the Nicholsons Community Planning Weekend to participate in workshops, walkabouts and hands-on planning sessions and co-create a vision for the new quarter. The resultant vision included a rich mix of uses, including shops and markets, cafes and restaurants, community uses, arts, culture and events, workspace and housing all set within an attractive street scene, with a flexible square as a new heart for the town; all to serve the whole community and be fully accessible for everybody.

Planning application

Over the last year the designs have been developed, with the benefit of significant community and stakeholder engagement, including a further public exhibition in July 2019. The resultant planning application has been submitted to RBWM and you will have the opportunity to comment as part of the Council's statutory consultation process.

Imagine a town alive and adventurous. Where High Street, King Street and Queen Street meet, you will find Maidenhead's new heart - the Nicholson Quarter.

The Nicholson Quarter is designed around a sequence of open streets and spaces that connect and knit into the town.

Moffatt Street is a new east-west street connecting King Street to the heart of the quarter. The place to... find provisions.

On Broadway is Sydenham Place; a new public space greening this street. A place to…let the good times roll.

King Street is repaired through the creation of new frontages. A place to...stay forever young.

Brock Lane is brought back to life. A key connection ...to the rest of the town.
