Background

Cotswold District Council (CDC) is preparing a Local Plan that will help shape the District in the future and land south of Chesterton, Cirencester has been identified as a strategic allocation for a mixed use, high quality and sustainable development.

Bathurst Development Ltd is preparing an Outline Planning Application (OPA) for the site, which will include up to 2,350 new homes to suit all needs, including elderly person and student accommodation; circa 100 acres of public open space; a wide variety of employment uses; a new primary school; a GP surgery; sports pitches; an indoor sports hall; community facilities; and all necessary services and infrastructure.

We have recently carried out a consultation on the Masterplan Framework Document (MPF). The comments received have helped inform the contents of the OPA.

The OPA will seek approval for the principle of development on the site and distribution of uses. Once submitted, the OPA will be determined by CDC following a formal period of public consultation carried out by CDC. The OPA submission will include detailed technical reports and assessments including transport proposals and supporting information relating to design.
